## ITINERARY

### Day 01 Manila / Mexico City via Los Angeles

Depart Manila on board a prestigious airline to Los Angeles City. After immigration formalities, board your flight to Mexico City. Upon arrival in Mexico City, transfer to your hotel for overnight.

### Day 02 Mexico City (B/L/D)

Drive to the Basilica de Guadalupe where a mass will be celebrated. This is the holiest shrine for millions of Mexicans. Also visit the Capilla De Las Rosas and Capilla Del Tepayac. Proceed to the Metropolitan Cathedral and the Zocalo. Rest of the day is free.

### Day 03 Mexico City-San Juan Teotihuacan (B/L/D)

Visit the Plaza de las Tres Culturas. The square contains the remains of Aztec temples and is flanked by the Catholic Church of Santiago de Tlatelolco. Proceed to San Juan Teotihuacan to inspect the awe-inspiring pyramids of the Sun and Moon and walk down the Road of the Dead to the Citadel to wonder at the extraordinary Temple of Quetzalcóatl with its stone-sculptured plumed-serpent heads. Return to Mexico City where the evening is free for individual activities. Overnight at the hotel.

### Day 04 Mexico City-Cholula-Puebla (B/L/D)

Proceed to Cholula, the town of 365 churches - one for every day of the year, so the saga goes that is also the site of Mexico's largest Pyramid which is still fully covered by weed and topped by a Catholic Church. Drive over a modern highway, affording breathtaking vistas of the rugged Sierra Madre mountain chains. Arrive in the historical city of Puebla for a comprehensive tour that includes the stately and impressive Cathedral, the downtown area which has preserved a strong Spanish-French flavour, and boasts an impressive number of historic and cultural monuments and buildings, including the exuberant, baroque Rosary Chapel and San Francisco Church. Countless constructions in the characteristic poblano style of bricks-and-tiles contribute to the city's particular physiognomy. Check-in and overnight at the hotel.

### Day 05 Puebla-Ocotlan-Mexico City (B/L/D)

Drive to the neighboring state of Tlaxcala and its similarly named capital city. A visit to San Miguel del Milagro comes next. This is the site of miraculous apparitions of St. Michael the Archangel to Diego Lázaro in 1631 and of a well of curative waters. Outside of this charming provincial town we visit the Shrine and Sanctuary of Our Lady of Ocotlán where an apparition is said to have occurred to Juan Diego Bernardino in 1541. Tradition has it that the Virgin left her statue in a burnt tree as proof of her apparition. But apart from its religious significance, the Sanctuary of Ocotlán also represents one of the high points of Mexican baroque art, its gleaming white stucco façade being a classical example of the Churrigueresque style. Drive back to Mexico City and visit once again the Basilica de Guadalupe. Check-in and overnight at the hotel.

### Day 06 Mexico City-Los Angeles-Anaheim (B)

Departure transfer to the airport for flight to Los Angeles City, USA. Arrive in the "City of Angels". Meet and greet with transfer to your hotel. Rest of the day is free at leisure.

### Day 07 Anaheim (Disneyland) (B)

Morning transfer for a full day at Disneyland, "the Happiest Place on Earth". Go on a magical journey in a kingdom of fantasy filled with family-friendly rides, shows and attractions combined with dining and shopping that only Disney could create.

### Day 08 Anaheim (Universal Studios) (B)

Visit Universal Studios where you may take an open train through the back lot that created some of the world's most famous movies.

### Day 09 Los Angeles / Manila (B)

Transfer to the airport for your flight back to Manila or to your next destination.

## TERMS AND CONDITIONS:

**DEPOSIT AND PAYMENT REQUIREMENTS.** A copy of your passport, deposit of SEVEN HUNDRED (USD700.00) DOLLARS, payment of USD300.00 U.S. Visa Service Fee and PHP14,500.00 U.S. Visa Processing Charges is required upon registration to cover for reservations deposits required by the airlines and/or tour operators and U.S. visa processing/interview appointment. This is non-refundable and non-transferable.

Full payment of the package shall be made immediately upon approval of the visa. For joiners with an already valid and existing U.S. visa, full payment shall be made at least sixty (60) days prior to departure date.

U.S. dollar payment is highly preferred to avoid fluctuations in the currency exchange rate. In case U.S. dollar payment cannot be avoided, the conversion rate shall be based on the prevailing *airline exchange rate* on the date of payment.

**CANCELLATION POLICIES AND GUIDELINES.** In case of cancellation, the following policies shall govern:

1. In case of denial of visa application thereby preventing the participant from proceeding with the tour, the deposit shall be refunded to the participant. The U.S. Visa Service Fee and Visa Processing Charges are non-refundable.
2. In case of cancellation of the tour due to lack of participants, the tour will be rescheduled to a later date and all deposits and payments already made will be credited towards the rescheduled tour subject to price adjustments (if any) due to revisions in the itinerary, increase in airline and fuel surcharges, price changes for visa and taxes, fluctuations in foreign currency exchange rates, and other factors.
3. In case the participant decides to withdraw from the tour after registration, the full deposit shall be forfeited to cover the costs of reservation/cancellation of tour and travel arrangements, communication and other services already rendered. In addition, the following cancellation charges shall apply:
  - ◆ 50% of the package price, if cancellation is made sixty (60) days prior to departure date;
  - ◆ 75% of the package price, if cancellation is made forty five (45) days prior to departure date;
  - ◆ Full amount of the package price, if cancellation is made thirty (30) days prior to departure date.

## OTHER TERMS & CONDITIONS.
